- C. All original certificates of full time staff of all courses should be produced during visits of visiting teams/or as and when asked by the competent approving authority.
- D. If any approved candidate leaves the institution on resignation or for any other reason, the matter should be brought to the notice of the undersigned within a week. The vacancy so arisen should be filled in within two months duly following the usual procedure and obtain the approval of the Director, SCERT.

If, any deviation is observed necessary action will be taken against the Management of said college.


